THIS IS TO CERTIFY, that we, the undersigned subscribers, namely, William Carney, Earl Loveland, Charles^{J.} Guenther, Henry F. Heitz, Charles Klein, John Fish, Richard Fitzpatrick, George Hudson, Jr. and Pete Berenato, do hereby associate ourselves into a Corporation, under and by virtue of the provisions of an Act of Legislature of the State of New Jersey entitled "An Act to incorporate associations not for pecuniary profit" Title 15 of the New Jersey Revised Statutes, 1937, the amendments thereof and supplements thereto, for a lawful purpose other than pecuniary profit, as hereinafter stated, and to that end we do hereby certify as follows:

FIRST: That the name or title by which the Corporation shall be known in law, is the "ATLANTIC COUNTY FIREMEN'S ASSOCIATION OF NEW JERSEY, INC."

SECOND: That the purpose of this Association is to bring together its members in order to discuss methods of betterment for the Fire Service; the reduction of loss of life and property from fire; the development of a better Fire Service through an educational program, and to foster the spirit of harmony and friendship among the various Fire Companies and Fire Departments in Atlantic County, New Jersey.

THIRD: The Association shall be located, and its principal activities shall be conducted in various municipalities in Atlantic County, New Jersey.
