



MR. DAHLGREN ALBERSTON OF VENTNOR WAS ELECTED TEMPERORY CHAIR MAN TO ACT AT THIS MEETING IN THE ABSENCE OF PRESIDENT BREDER.

MR. DELIVERED AN ADDRESS OF WELCOME ON BEHALF OF THE LANDISVILLE-MINOTOLA CHAMBER OF COMMERCE.

THE MINUTES OF THE PREVIOUS WERE READ AND APPROVED.

SECRETARY SCUKK STATED THERE ARE SIXTEEN COMPANIES REPRESENTED IN THE ASSOCIATION AND THERE ARE ONLY 184 INDIVIDUAL MEMBERS AND THOUGHT THE INDIVIDUAL MEMBERSHIP SHOULD BE INCREASED. CHAIRMAN ALBERSTON ALSO SPOKE ON THE MEMBERSHIP. MR. ARMSTRONG SPOKE ON THE MEMBERSHIP OF THE DEATH BENEFIT FUND AND SAID HE THOUGHT THAT SHOULD BE INCREASED ALSO.

MR. FRINGS INVITED ALL FIREMEN TO BRING THEIR WIVES AND SWEET-HEARTS AND COME TO VENTOOR ON THURSDAY EVENING AUGUST 21ST TO A DANCE GIVEN BY THE VENTOOR CITY FIRE DEPARTMENT ON THE MUNICIPAL PIER.

CHAIRMAN GILMORE STATED THAT THE ENTERTAINMENT COMMITTEE HAD CONSIDERED HAVING A LADIES NIGHT ON THE REGUKAR MEETING NIGHT IN SEPTEMBER AT ABSECON AND ASKED IF THE ASSOCIATION WOULD GIVE SOME FINICIAL ASSISTANCE TOWARDS THE EXPENSES. MR. FRINGS SAID IF IT WAS HELD IN SEPTEMBER IT WOULD COME ON THE WEDNESDAY NIGHT AFTER THE FIELD DAY AND HE THOUGHT IT WOULD BRING THE TWO TOO CLOSE TOGETHER. AFTER QUITE SOME DISCUSSION IT WAS REGULARLY MOVED AND SECONDED THAT THE LADIES NIGHT BE HELD IN HAMMONTON ON OUR REGULAR MEETING NIGHT IN OCTOBER AND THAT THE ENTERTAYN.COMMITTEE GET IN TOUGH WITH THE HAMMONTON DEPT AND ASCERTAIN HOW MUCH FINICIAL ASSISTANCE WOULD BE NEEDED.

MR.GILMORE NAMED OVER THE EVENTS THE ENTERTAINMENT COMMITTEE SUGGESTED BE PUT ON DURING THE FIELD DAY. CHAIRMAN ALBERSTON

SAID THE ENTERTAINMENT COMMITTEE WERE A GOOD LIVE COMMITTEE AND THOUGHT THEY SHOULD BE ABLE TO PUT ON SOME SUPRISE STUNTS. MR. PHILLIPS MADE A MOTION WHICH WAS SECONDED THAT THE ASSOCIATION APPROPRIATE \$50.98 TO DEFRAY THE EXPENSES OF THE FIELD DAY.

MR.PHILLIPS STATED THAT THE QUESTION OF HOW MANY LADIES NIGHTS BE HELD A YEAR AND HOW MUCH ASSISTANCE BE GIVEN THE COMPANY WITH WHICH IT IS HELD SHOULD BE SETTLED AND MADE A MOTION THAT THE ASSPCIATION HOLD ONE LADIES NIGHT A YEAR AND ON INVITATION OF THE COMPANY WITH WHICH IT WILL BE HELD AFTER QUITE SOME DISCUSSION BY MEMBERS OF THE ASSOCIATION THIS MOTION WAS CARRIED BY A RISING VOTE OF 29 FOR AND 21 AGAINST THE MOTION.

VICE-PRES ROYAL MADE A MOTION THAT WE EXTEND AND INVITATION TO THE VOLUNTEER FIREMENAND OF ATLANTIC CITY TO MEET WITH US AS HONOR-ARY MEMBERS, MR.PHILLIPS STATED THERE HAD BEEN NO PROVISION MADE IN THE CONSTITUTION OF THE ASSOCIATION FOR HONORARY MEMBERS AND WITHOUT MAKING A CHANGE IN THE BONSTITUTION HONORARY MEMBERS COULD NOT BE TAKEN IN, THIS MOTION WAS NOT CARRIED.

VICE-PRES ROYAL THEN MADE A MOTION WHICH WAS CARRIED THAT THE EXECUTIVE COMMITTEE MEET AND AMEND THE CONSTITUTION SO THAT HONORARY MEMBERS GOULD BE ADMITTED.

MR. SCHUSLER ASKED ABOUT THE PHYSICIAL EXAMINATION FOR NEW MEMBERS COMING INTO THE DIFFERENT DEPARTMENTS. VICE-PRES ROYAL STATED THAT ALL THE SATISFACTION HE HAD BEEN ABLE TO GET FROM THE STATE RELIEF ASSOCIATION WAS THAT IF A MAN WAS REGARDED AS PHYSICALLY ABLE BY THE DEPARTMENT HE WISHED TO BECOME A MEMBER OF FOR THAT DEPT TO TAKE HIM IN AS A MEMBER.

FIVE NEW INDIVIDUAL MEMBERS WERE TAKEN IN.
