Roll Call was taken to ensure a quorum being present.

Minutes of the previous meeting of December 21st, 1994 were approved and accepted as forwarded to the Chiefs and Secretaries.

The Report of the Treasurer was approved and accepted as read.

Frank Pratzner was presented a Plaque from the Association as a token of appreciation for having served as Treasurer for the past 23 years. Frank thanked the membership for the presentation.

Lou Raciti of Landisville, the incoming treasurer is to assume these duties following the retirement of Frank: Lou served on the Execuitve Committee for several years and is moving up.

The Report of the Executive Committee meeting of January 6th, 1995 was approved and accepted as read by the Secretary. Anthony Canale was selected as Chairman, Howard Berchtold Jr. as Assistant Chairman, and Howard Guenther as Secretary of the Executive Committee for 1995. The Executive Committee recommended that \$5000.00 be borrowed from the Trip Account for the Training Program subject to reimbursement and a motion was made, seconded and carried to approve this recommendation.

The Executive Committee also recommended the purchase of 4 or 5 of the memorial windows as spares if they are available and a motion was made, seconded and carried to approve this recommendation.

The Secretary reported that he has received the memorial window for Reverend String, which will be presented to his family. Howard also reported that the manufacturer of the windows has gone out of business and they are in short supply, however, he will try to acquire more as spares.

John V. Wagner gave a report on the Advisory Council meeting.

Fire Coordinator Beau Endres reported that all is quiet on the fire scene at present. Barry Bruner gave a report on the Juvenile Fire Setting program for 1994.

The Fire Training Committee reported that applications for the training courses are starting to come in, however, a check or voucher must accompany the application to be enrolled in the course.

All materials have been received for the LP pad and construction is to begin shortly on this. Also in the works are confined spaces mockup and an electrical mockup. Help is needed on these projects and any help given will be greatly appreciated.

Progress is being made with the Bureau of Fire Safety on acquiring the Eligibility Number for firefighter training. The County is making changes in the resolution which will make the Atlantic County Firefighters' Association the authorized signature for firefighter training. Motion seconded and carried authorizing any necessary resolution, etc. to finalize this Number for the Association.

The Valor Awards Committee reported that the presentation of the awards is to be held at the April 19th meeting of the Firefighters' Association which is scheduled to be held at the Atlantic County Fire Training Center. Information is to be forwarded shortly to all companies requesting nominees for the Valar Awards.

Frank Pratzner reported that the meeting of the Trustees of the Atlantic County Firemen's Death Benefit Fund is scheduled for Monday, January 30th in Absecon at 7:00 PM.

The Budget for the Association for 1995 will be presented at the next meeting as well as the report of the Auditing Committee.
