

A report was given on Senate Bill S-258 which modifys payment of workers' compensation benefits for certain volunteers injured while volunteering. This would cut back benefits of those volunteers employed on job to benefit based on their salary at work and if retired would provide no compensation benefit as retirees do not receive any work pay to base their benefit on. This was passed in the Senate by a vote of 30-2-0 on March 27,2000 and is now referred to Assembly Labor Committee.

As this Senate Bill has passed the Senate and is now in the Assembly Committee, we must phone our Assemblymen and follow up with letters requesting them to oppose this bill when presented for vote in Assembly and it is detrimental to the volunteers.

Assembly Bill A-532 which would increase amount that a County could appropriate for Training and Communications was reported out of committee on February 10th. We must also phone our Assemblymen and follow up with letters requesting them to vote favorably on this bill as it would greatly increase the amount of money that we could receive for training. We should also contact Assemblyman Jack Collins (R-3rd) requesting him to post this bill for a vote in the Assembly. Once passed in the Assembly, then we must contact our Senators for their support.
