Ted Reinhard reported that he has forwarded his "wish list" to several manufacturers and has received replies and that we are to receive some LDH Storz fittings as well as forcible entry tools for use at the Fire Training Academy as donations from them. Ted also reported that several additional books have been donated for the library. Ted was thanked for his efforts in making these contacts and acquiring the donations of equipment.
