Finance Committee - Howard Berchtold Jr. reported on the ongoing review of the finances with the accountant and the auditor. It has been identified that Sec.1 of Art. Fire Coordinator – Oscar Dutch reported on the recent southern regional coordinators meeting and the current status of the FireTrax and Fedco systems.

Notices will be sent out to all county fire chiefs seeking applicants for open instructor positions.

Atl. Co. Fire Chief's Association – Chief Jim Garth reported that the next meeting is scheduled for July 29, 2008 in Estell Manor.

NJ Fireman's Home – Oscar Dutch reported on the ongoing efforts to establish a second home, or a wing in an established home, in South Jersey.

4H Fair – Scheduled for Aug. 7, 8, and 9. Howard Berchtold reported on the plans for the apparatus display and the Friday night firefighter competition. Gene Wellington reported further on the competition plans and the push to get more apparatus displayed. Gene also reported that they will add some events that children may participate in.
