## **Special Presentations and Installation of Officers for 2015**

All of the invited guests addressed the membership and expressed their appreciation for all that the firefighters do for their local communities and for Atlantic County.

President Amor "Skip" Portale read the following statement.

"Good evening and welcome to the Atlantic County Firefighters' Association's 92<sup>nd</sup> annual reorganization meeting hosted once again by the Egg Harbor City Fire Department as it has been since 1924. Since 1923 the primary duties of the Atlantic County Firefighters' Association has been to provide training to all firefighters from Atlantic County. While at the same time offering training to firefighters from throughout the state. This would not be possible without the assistance of Atlantic County Executive Dennis Levinson and his staff, The Board of Chosen Freeholders, Retired Fire Marshal and Academy Director Whitey Swartz, Director of Emergency Preparedness Vince Jones, and the Director of Training Mike Corbo along his dedicated staff of instructors. 2014 was another very productive year for the association. Some of the accomplishments achieved in 2014 are as follows. We continue to partner with West Virginia University in the delivery of a First-Responder training program on alternative fuel vehicles. Our academy continues to deliver Pro-Board and IFSAC accredited courses supported by the NJ Division of Fire Safety. Started a joint venture with Gloucester County Fire Academy to instruct the Heavy Vehicle Rescue course in the spring at our academy and in the fall at theirs. We trained 93 new firefighters from 27 different Atlantic County companies and 15 new firefighters from out of county. We also trained our first out of state firefighter. This year's classes included firefighters from the counties of Atlantic, Cape May, Cumberland, Salem, Ocean, Camden, Gloucester, and the State of Pennsylvania. In 2014 the Firefighters' Association held over 61 different classes with 921 firefighters being trained through academy offered courses and 1,625 students being trained overall. Of that number, 342 students were from out of county. The total number of instructor hours incurred by our 36 instructors in 2014 was 3,601. As in years past, we were able to operate within our budget. We added 4 new members to our dedicated team of instructors and we welcomed our first, but certainly not last, female instructor to meet the ever changing needs of the fire service. We conducted the annual memorial service to honor our fallen firefighters. We recognized firefighters from Atlantic County with 50 or more years of service. We sponsored the annual valor awards ceremony. We again sponsored the annual firefighter's competition held at the Atlantic County 4H Fair in August and in 2014 we introduced a junior firefighter's competition as part of our regular firefighter's competition. We acquired 3 new sets of turn out gear and additional equipment at no cost to county government, or the taxpayers of Atlantic County, to meet our ever increasing training demands. As we begin 2015, I look forward to working with County Executive Levinson, the Board of Chosen Freeholders, county government, our new Fire Marshal, Dave Buzby, as well as the members of the executive committee and the Director of Fire Training Mike Corbo to keep the Atlantic County Firefighters' Association one of the best in the state."

Executive Committee Chairman Howard Berchtold Jr. welcomed all those in attendance to the annual meeting and memorial service on behalf of the Executive Committee. Howard thanked his wife, Donna Marie, for joining him in the singing of the "Lord's Prayer" and his daughter, Heather, along with Joe Ward for the playing of "Taps". Howard thanked all of the families that support the firefighters. Howard thanked all of the association officers and committee chairmen for the hard work that they do. Howard thanked all of the county government, including the Freeholders and the Dept. Heads, which have provided much assistance with keeping the association going strong. Howard noted that he is proud to have again been reelected as Chairman of the Executive Committee and that Oscar Dutch Jr. has been reelected Vice Chairman. Howard thanked Secretary Mellon on all of the work preparing the 501(c)(3) application. Howard also thanked the Atlantic County Fire Chiefs' Association for the concerted effort with moving central dispatch to a final reality. Howard, along with President Portale, reported that the plaque presented to Whitey Swartz in April 2014 will be recreated with a photo of Whitey and placed at the training center. Whitey Swartz noted that he started many projects but they only got done because of all the excellent assistance he has received throughout the years.
