

December 20, 2017

Call to Order

The regular meeting of the Atlantic County Firefighters' Association was called to order at 20:00 on December 20, 2017 at the Farmington Volunteer Fire Company by President Amor "Skip" Portale. The meeting was opened with a flag salute followed by an Invocation by the Chaplain of the Association, Reverend Thomas Sweeny. President Portale then pointed out the fire exits and asked that all electronic devices be silenced.

Introduction of Host Chief

President Portale introduced President James Garth Sr. of the Farmington Volunteer Fire Company. President Garth welcomed all to Farmington on behalf of the chief and members, thanked everyone for attending, and introduced Egg Harbor Township Fire Department Chief C. Robert Winkler III. Chief Winkler welcomed all on behalf of the entire Egg Harbor Township Fire Department and wished all a Merry Christmas and Happy New Year.

In Attendance

Roll call was taken by Secretary Robert A. Mellon who reported a quorum was present. Total Chief/Delegate Attendance – 43 of 176 Total Member Departments/Companies Represented – 18 of 44

Special Presentation

President Portale reported that in an effort to keep moving forward with the presenting of information concerning health and wellness, Carolyn Quinn, Mental Health Association in Atlantic County, had been invited to present information about their new Atlantic County Hoarding Task Force and the Hoarding Disorder Initiative. Carolyn reported on the recent efforts to establish the new programs to help identify those within the Atlantic County population of approximately 243,000 that fall within the various levels of hoarding. Carolyn gave a presentation on what hoarding is and the associated stigmas associated with hoarding. Resources were identified that are now available to assist Atlantic County residents including a grant funded program with a goal of reaching out to assist those residents that meet certain criteria. Carolyn reported that the task force and initiative program is the first of its kind in New Jersey and only the fifth program in the country. Handouts with program information and contact numbers were distributed. Carolyn reported that the program is seeking input from all public safety sectors, including the county fire service, as to what they see when out in homes and asking that handouts be left with residents so that they may decide if they would be interested in contacting the program for assistance.

Approval of Minutes

A motion was made, seconded, and carried to approve the minutes of the November 15, 2017 meeting, as sent to the member companies.

Report of Treasurer

A motion was made, seconded, and carried to accept the report of the Treasurer, totaling \$151,019.29, as read by Treasurer Jaime C. Mellon.

Committee Reports

Executive Committee – Chairman Howard Berchtold reported that the next meeting of the Executive Committee is scheduled for January 5, 2018 in Pomona at 19:30 and will be the reorganizational meeting for 2018. Howard commented that the presentation about hoarding was very good and that the plan is to keep seeking programs concerning health and wellness for the 2018 meetings. Howard reminded all to slow down once and a while, take a breath, and count your blessings. Howard wished all a Merry Christmas and Happy New Year.

Atlantic County Fire Training Advisory Board – Howard Berchtold reported that the next meeting of the Advisory Board is scheduled for January 8, 2018 at the Anthony "Tony" Canale Training Center. The board will be reviewing the possibility of moving to quarterly meetings, instead of every two months.

Fire Coordinator –Fire Coordinator Lefty Clayton reported that he will be reaching out to the Deputy Fire Coordinators to schedule a meeting with them in January. Lefty reported that mutual aid plan updates are due in January and that the FY2017 Homeland Security Grant spending plan will require updated price quotes for equipment by January 16th. Lefty reminded all that the FY2018 grant requests will be required to meet the current initial justifications (IJs) for Homeland Security Grants.

Harold J. "Whitey" Swartz Valor Awards and Service Recognition – Lefty Clayton reported that he recently held a committee meeting and only two others attended. Lefty requested that additional people join this committee and noted that someone will need to chair the committee as he will not be able to. The application and award approval process need to be reviewed. Tom Sweeny reported that he will draft the "Letter of Accommodation" if it were to be added to the available awards. A letter of accommodation would be the initial level of recognition.

Fire Marshal – Dave Buzby reminded all to notify him no later than January 9th of any firefighter deaths in 2017 for inclusion in the annual memorial service program on January 17, 2018.

Training – Director of Training Mike Corbo reported that the Firefighter I class has completed. Mike reported that the spring semester course book should be completed before the January meeting of the association. Mike informed all that the fall semester Firefighter I graduation ceremony will be held at 7:00 PM on Monday, January 29, 2018 at the training center. The spring semester Firefighter I will start on Thursday, February 8th and Firefighter II will start on Monday, March 5th. Mike reported that Fire Officer I will start on January 2nd and Fire Officer II will start on January 3rd or be cancelled if there are not enough enrolled students by then. Mike reported that he attended a NJ Fire Training Committee meeting where much of the time was spent discussing the requirements for junior firefighters. Many conflicting requirements under NJ law were discussed. NJ PEOSH limits juniors to instruction on firefighter gear and protection. Title 40A bars those under the age of 16 from any hazardous duties while not addressing ages 16 and 17. The NJ Department of Labor Wage and Hour Division does not allow for anyone under the age of 18 from wearing a pressurized air cylinder and also considers junior firefighters as public employees requiring they be covered by workers compensation insurance. Mike noted that there are no current plans to better organize the multiple rules covering junior firefighters in NJ and that every existing junior firefighter program in the state is run differently. Mike reported on the AtlantiCare Cardiovascular Evaluation Program for First Responders and provided handouts about the program. The program is completely free and they have not even asked for insurance coverage information from those that have insurance. The program is not as extensive as the Captain Buscio program but may be completed annually when Deborah Heart and Lung may only have someone repeat the Buscio program every two or three years. Mike thanked the fire academy instructors for their hard work throughout the past year. Mike reported that many classes were canceled in 2017 due to low enrollment, but that trend has affected all training programs in the state. Mike thanked Executive Committee Chairman Howard Berchtold, the Executive Committee, President Skip Portale, and Officers of the Association for working with him. Mike wished all Merry Christmas and a Happy and Safe New Year.

Atlantic County Fire Chiefs' Association – Butch Kienzle reported on the December 13th meeting of the Atlantic County Fire Chiefs' Association held in Sweetwater. Nominations and election of officers for 2018 was conducted. The next meeting of the Atlantic County Fire Chiefs' Association will be 8:00 PM on January 23, 2018 at the Absecon Volunteer Fire Department and there will be no meeting in February. Butch wished all a Merry Christmas and Happy New Year.

NJ Firemen's Home – Oscar Dutch reported that working with the NJSFA officers has been going well. Oscar wished all a Merry Christmas and a Happy New Year. On a personal note, Oscar reported that he will not be continuing as a Deputy Fire Coordinator after twenty-one years of service and thanked all that have worked with him over those years.

NJ State Firemen's Assn. – Cindy Badger reported that the local associations of the NJSFA are required to elect officers at their December meeting. The NJSFA office will be closed until January 2nd. The local officer listing report is due by February 1st. Local relief reports are due by January 30th. Annual financial reports are due by January 20th. Annual membership reports are due by February 28th. Delegate convention reports are due by May 1st. IRS990 copies are due by May 15th. The local relief application has been revised, dated January 2018, and is available online. Cindy reviewed some of the changes to the application and noted that instructions now further clarify what the definition of need is and that copies of all documentation needs to be reviewed and attached. Cindy reminded all that relief applications are confidential and should not be discussed outside the normal course of business. Two new voting machines will be purchased for the convention and Atlantic County had seven delegates achieve life member status at the 2017 convention. Cindy reported that thirty-two applications had been received for the new NJSFA long term healthcare program. None were from Atlantic County. Statewide, one hundred forty-seven applications for special relief were approved. Two Atlantic County locals will not be seated at the 2018 convention. Cindy wished all a Merry Christmas and a Happy New Year.

Dissolution must be approved by a majority vote of the member fire companies' delegates at two consecutive monthly meetings.

SECTION 3: DISSOLUTION Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

6) <u>ADD</u>

ARTICLE X

SECTION 4: PURPOSE Said corporation is organized exclusively for charitable, religious, educational, and/or scientific purposes, included, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

SECTION 5: NET EARNINGS No part of the net earnings of the corporations shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth.

SECTION 6: POLITICAL ACTIVITY No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

1) <u>CHANGE</u>

ARTICLE II MEMBERSHIP

Current:

SECTION 2: Application for individual non-voting membership shall be accompanied by the entrance fee and dues for the current year.

Proposed:

SECTION 2: Non-voting membership shall be those individuals that are current members of the member Fire Companies.

2) <u>CHANGE</u>

ARTICLE II MEMBERSHIP

Current:

SECTION 5: Special dispensation may be made for out of County Fire Companies for their participation in meetings and social events of this Association without privilege of voting. Dues shall be on the same basis as individual non-voting members of regular member Fire Companies.

Proposed:

SECTION 5: Special dispensation may be made for out of County Fire Companies for their participation in meetings and social events of this Association without privilege of voting. Dues shall be on the same basis as regular member Fire Companies.

3) <u>CHANGE</u>

Current: <u>ARTICLE III</u> ENTRANCE FEES AND DUES

SECTION 1: Entrance fee and dues for one year for member Fire Companies shall be in the sum of sixty (\$60.00) dollars payable, upon acceptance in the case of new members, or by the Regular Meeting in January of this Association in the case of present member Fire Companies.

SECTION 2: Entrance fee of one (\$1.00) dollar and dues of three (\$3.00) dollars for the remainder of the current year shall be submitted by individual non-voting members. Each year thereafter dues of three (\$3.00) dollars shall be submitted by the Regular Meeting in January of this Association.

5) <u>CHANGE</u>

<u>ARTICLE V</u> ELIGIBILITY OF OFFICERS

Current:

SECTION 1: To be eligible for the office of President, First Vice President, or Second Vice President, a member must be a delegate, chief officer or past chief officer of his company at the time of his election but does not have to remain in that category after said election.

Proposed:

SECTION 1: To be eligible for the office of President, First Vice President, or Second Vice President, a member must be;

A: in good standing with their member Fire Company

and

B: a current, or past, delegate - or - current, or past, chief officer, of their member Fire Company

at the time of their election to office, but does not have to remain in that category after said election.

SECTION 2: The Office of Secretary, Treasurer, Assistant Secretary-Treasurer, Chaplain, Sergeant-at-Arms, and members of the Executive Committee may be held by any member, in good standing with their member Fire Company, whether they are a voting or non-voting member.

They will also review and make recommendations on any matters before the Association as referred to them by the President at his/her discretion.
