

April 20, 2022

Call to Order

The regular meeting of the Atlantic County Firefighters' Association was called to order at 19:40 on April 20, 2022 at the Atlantic County Anthony "Tony" Canale Training Center by President Charles J. Mackintosh. The meeting was opened with a flag salute followed by a moment of silence in remembrance of all fallen firefighters and military personnel. President Mackintosh then pointed out the fire exits and asked that all electronic devices be silenced. President Mackintosh welcomed all to the meeting which serves as the twenty-ninth annual Valor Awards presentation and the eleventh annual recognition of firefighters with fifty or more years of active service.

Opening Remarks and Introduction of Host Chief

President Mackintosh reported that both Chaplain Rich Maxwell and Howard Berchtold were unable to attend and have sent their regrets. Vice President Dennis C. Sharpe read remarks and a prayer on behalf of Chaplain Maxwell. President Mackintosh thanked the Margate City Fire Department for hosting and introduced Chief Daniel Adams. Chief Adams welcomed everyone to the annual valor awards and expressed how proud the Margate City Fire Department is to be hosting the awards for the tenth year. Chief Adams spoke about those having achieved fifty years of service, the amount of training attended over the years, and the many missed meals and family events due to answering the call to service. Chief Adams then read a quote from Chief Edward F. Croker, Chief of Department FDNY 1899-1911. "I have no ambition in this world but one, and that is to be a fireman. The position may, in the eyes of some, appear to be a lowly one; but we who know the work which the fireman has to do believe that his is a noble calling. Our proudest moment is to save lives. Under the impulse of such thoughts, the nobility of the occupation thrills us and stimulates us to deeds of daring, even of supreme sacrifice." Chief Adams thanked all for attending on behalf of the Margate City Fire Department and ended his remarks by asking everyone to join him in reciting "A Fireman's Prayer".

Approval of Minutes

A motion was made, seconded, and carried to approve the minutes of the March 16, 2022 meeting, as sent to the member companies.

Dispensing of Business

A motion was made, seconded, and carried to dispense with the regular business except for the paying of the bills.

<u>Bills</u>

The bills were read by Treasurer Jaime C. Mellon. A motion was made, seconded, and carried to pay the bills from the proper funds.

Introduction of "Harold J. "Whitey" Swartz Valor Awards and Service Recognition"

President Mackintosh welcomed all to the awards presentation and "50" year service recognitions. President Mackintosh reported that twenty-two firefighters will be honored for having achieved fifty years of service. President Mackintosh thanked all valor award recipients for having the courage to do what needed to be done and then also thanked the "50" years of service recipients for having the dedication and commitment for all those years. President Mackintosh reported that Atlantic City Firefighter Anthony Michael Carfagno will be honored after the awards with a ceremony to add a leaf bearing his name to the Tree of Fallen Heroes. Firefighter Carfagno died in the line of duty on December 21, 2021 following a battle with COVID-19. President Mackintosh introduced Deputy Chief Thomas J. Culleny, Jr., Atlantic City Fire Department. Deputy Chief Culleny spoke about Firefighter Carfagno's dedication to the job and to the community where he dedicated time caring for a community garden. Deputy Chief Culleny noted the Atlantic City Fire Department recognizes the significance of having added another name to the Tree of Fallen Heroes.

President Mackintosh welcomed and introduced guests; NJ Assemblyman Donald A. Guardian; Atlantic County Commissioners: Chairwoman Maureen Kern, Vice-Chairman John W. Risley Jr., and James A. Bertino; Atlantic County Clerk Joseph J. Giralo; Atlantic County Surrogate James Curcio: and Atlantic County Director of Public Safety Michael A. Fedorko.

Valor Awards

President Charles J. Mackintosh presented each of the Valor Award recipients with their awards from the Atlantic County Firefighters' Association. This is the twenty-ninth year of the Valor Awards presentation. Recipients have included firefighters, police officers, medical personnel, and civilians. All honorees also received recognitions from NJ Senator Vincent J. Polistina, Assemblyman Donald A. Guardian, and Assemblywomen Claire S. Swift; the Atlantic County Board of County Commissioners; and Atlantic County Executive Dennis Levinson. Unfortunately, not all honorees were able to be in attendance. Those honorees will receive their awards at a future meeting or have them sent to their department for presentation.

President Mackintosh introduced Ken Badger Sr., Mays Landing Volunteer Fire Company, who provided a summary of the rescue on January 16, 2021. Multiple Hamilton Township Fire Companies were dispatched for a structure fire at the Sandpiper Condominium Complex on January 16, 2021. The first arriving firefighters from Mays Landing Volunteer Fire Company, Tanker 1819, stretched a line, made entry, and removed a single victim during their primary search. The victim made a full recovery after hospitalization due to smoke inhalation.

<u>"50" Year Service Awards</u>

President Charles J. Mackintosh presented each of the "50" Year Service Award recipients with a uniform bar (IOU due to supply delay), gold life member card (IOU due to supply delay), and framed certificate from the Atlantic County Firefighters' Association. This is the eleventh year of the annual recognition of firefighters with fifty or more years of active service. The honorees also received recognitions from NJ Senator Vincent J. Polistina, Assemblyman Donald A. Guardian, and Assemblywomen Claire S. Swift; the Atlantic County Board of County Commissioners; and Atlantic County Executive Dennis Levinson. Vice President Dennis C. Sharpe introduced Chief Gary P. Franklin, Sweetwater Volunteer Fire Company. Chief Franklin spoke of "The Sweetwater Six" who were a group of women who were aware of a daytime firefighter shortage in 1988. They joined the Sweetwater Volunteer Fire Company and trained to become dedicated firefighters who still serve today. Chief Franklin shared a plaque that honors their dedication by dedicating the Sweetwater Firehouse meeting room in their honor. "The Sweetwater Six" are Diane Cheatham, Mary Ann Clay, Barbara Craig, Peggy Franklin, Mary Ann Knuth, and Eileen Reichenbach.

Tree of Fallen Heroes Ceremony

In addition to honoring those for their service and valor, a ceremony to add a leaf bearing the name of fallen Firefighter Anthony Michael Carfagno to the Tree of Fallen Heroes was held. Firefighter Carfagno, Atlantic City Fire Department, died in the line of duty, on December 21, 2021, following a battle with COVID-19. The Tree of Fallen Heroes was installed at the Anthony "Tony" Canale Training Center in 2007 to honor all the Atlantic County first responders (police, fire, and EMS) that have died in the line of duty.
