## **Call to Order**

The regular meeting of the Atlantic County Firefighters' Association was called to order at 19:30 on December 21, 2022, at the Farmington Volunteer Fire Company, by President Charles J. Mackintosh. The meeting was opened with a flag salute followed by an Invocation by the Chaplain of the Association, Deacon Rich Maxwell. Chaplain Maxwell asked everyone to remember, and keep in prayers, those that have recently passed, and their families, including Chief Ed Vincent, Firefighter Eric Peace, and Chief Chuck Mackintosh. President Mackintosh then pointed out the fire exits and asked that all electronic devices be silenced.

## **Introduction of Host Chief**

President Mackintosh introduced Assistant Chief Dennis Sharpe of the Farmington Volunteer Fire Company. Assistant Chief Sharpe welcomed all to Farmington and introduced Egg Harbor Township Chief Rob Winkler. Chief Winkler welcomed all to Egg Harbor Township on behalf of all the fire companies and auxiliaries and wished everyone a Merry Christmas and a Happy New Year.

## **In Attendance**

Roll call was taken by Secretary Robert A. Mellon who reported a quorum was present.

## **Approval of Minutes**

A motion was made, seconded, and carried to approve the minutes of the November 16, 2022 meeting, as sent to the member companies.

## **Report of Treasurer**

A motion was made, seconded, and carried to accept the report of the Treasurer as read by Treasurer Jaime C. Mellon.

## **Committee Reports**

**Executive Committee** – Chairman Howard Berchtold reported that the next meeting of the Executive Committee is scheduled for January 6, 2023 in Pomona at 19:30 and will be the reorganizational meeting for 2023.

**Atlantic County Fire Training Advisory Board** – Howard Berchtold reported that the next meeting of the Advisory Board is scheduled for January 9, 2023 at the Anthony "Tony" Canale Training Center. Howard reported that Atlantic County had the job posting for the Director of the Fire Academy open for four weeks. Howard reported that representatives from the Board will work with the County to conduct interviews in early January.

**Atlantic County Radio Communications** – Howard Berchtold reported that there has been a good working conversation with Atlantic County. The County will be seeking a grant to conduct an updated feasibility study. Howard reported that an email went out to the chiefs requesting comments and input. A Fire, EMS, Police study will be done along with the Fire, EMS only study to look at the financial impact of the Next Generation 911 updates required for all PSAP/Dispatch centers. The Committee will meet again on January 10, 2023 at the Anthony "Tony" Canale Training Center.

**Training** – Director of Training Mike Corbo reported that he will send out all the fall 2022 invoices by the end of December. Mike reported that he is looking to get the Spring 2023 Course Book posted and sent out in January. Mike reported on attending the NJ Training and Education meeting. They are working on updating the 2015 code to the 2018 code and there will be an online class for Fire Inspectors and Officials. They voted to again offer a Firefighter II challenge test. The challenge test will still follow the original guidelines. The test is only open to those that have five years in the fire service prior to 2008. One challenge test will be hosted in Atlantic County. The test will consist of one hundred questions from the current James & Bartlett textbook. Only one attempt will be allowed for the challenge test. Mike reported that the fall Firefighter I class had just finished and that he will schedule a graduation ceremony in January. Mike wished all Merry Christmas and Happy Holidays.

**Fire Marshal** – Fire Marshal Dave Buzby reminded everyone to notify him, or Secretary Mellon, of any firefighter deaths in 2022, no later than January 11<sup>th</sup>, for inclusion in the annual memorial service program on January 18, 2023. Dave wished all a Merry Christmas and Happy New Year.

**Fire Coordinator** – Fire Coordinator Clyde W. “Chip” Stockton Jr. reported that an email was sent out about the SARS training scheduled for January 28 and 29 in Weymouth. There are ten openings for the class and additional classes may be scheduled if there is enough interest. Chip reported that Atlantic County is seeking to implement a SARS trained team at the county level. Chip reported that there are three new Fire Chiefs in the county. Chief Joe Kaspar, Minotola Vol. Fire Company. Chief Chris Tilley, Laureldale Vol. Fire Company. Chief Mike Sweeney, Somers Point Vol. Fire Department. Chip reported on a pending foam delivery and noted that there is no update on how or where to dispose of old foam. Chip wished everyone a Merry Christmas and a Healthy, Happy New Year.

**Atlantic County Fire Chiefs’ Association** – Butch Kienzle summarized the minutes of the meeting of the Atlantic County Fire Chiefs’ Association held on December 14, 2022 at the Sweetwater Volunteer Fire Company. Nominations and election of officers for 2023 was conducted. All current officers will continue in 2023. Butch reported on discussion about Salem County creating and training people for a fire support position that would include almost all aspects of the fire service, except for interior firefighting, after one hundred and twenty hours of training. Mike Corbo reported that the NJ DFS has not sanctioned the job title. Butch reported that some of the equipment has started arriving through the Egg Harbor City sponsored regional grant. The next meeting of the Atlantic County Fire Chiefs’ Association will be 8:00 PM on January 24, 2023 at the Absecon Volunteer Fire Department and there will be no meeting in February. Butch wished all a Merry Christmas and Happy New Year.

**Harold J. “Whitey” Swartz Valor Awards and Service Recognition** – Billy Merola reported that one nomination has been received and that a meeting to review will be scheduled in January.

**100<sup>th</sup> Anniversary** – President Chuck Mackintosh reported that the 100<sup>th</sup> Anniversary Committee will be meeting after the meeting. Anyone wishing to join the committee should see him after the meeting.
