

Call to Order

The regular meeting of the Atlantic County Firefighters' Association was called to order at 20:05 on April 18, 2018 at the Atlantic County Anthony "Tony" Canale Training Center by President Amor "Skip" Portale. The meeting was opened with a flag salute followed by an Invocation by the Chaplain of the Association, Reverend Thomas Sweeny. President Portale then pointed out the fire exits and asked that all electronic devices be silenced. President Portale welcomed all to the meeting which serves as the twenty-seventh annual Valor Awards presentation and the ninth annual recognition of firefighters with fifty or more years of active service.

Opening Remarks and Introduction of Host Chief

President Portale thanked the Margate City Fire Department for hosting and introduced Chief Daniel Adams. Chief Adams welcomed everyone to the annual valor awards and expressed how proud the Margate City Fire Department is to be hosting the awards for the eighth year. Chief Adams reflected eight years back when the Margate Fire Department was contacted by Whitey Swartz and asked to take over hosting the April meeting and awards ceremony. The Margate Fire Department was honored to be offered that privilege and their union, FMBA Local 41, volunteered to supply the refreshments. Chief Adams spoke about how providing the best service possible is what the fire service does and those receiving valor awards exemplify that best possible service. The eight being honored for fifty years of service have reached a milestone that very few do and their level of dedication to providing a great service to residents of Atlantic County for many years is quite an accomplishment and Chief Adams applauded them for that. Chief Adams thanked all for attending on behalf of the Margate City Fire Department and then ended his remarks with a quote from Chief Edward F. Croker, Chief of Department FDNY 1899-1911. "... When a man becomes a fireman his greatest act of bravery has been accomplished. What he does after that is all in the line of work..."

Introduction of "Harold J. "Whitey" Swartz Valor Awards and Service Recognition"

President Portale welcomed all to the awards presentation and "50" year service recognitions. President Portale thanked all valor award recipients for having the courage to do what needed to be done and then also thanked the "50" years of service recipients for having the dedication and commitment for all those years. President Portale also thanked the valor awards committee for the tough job of reviewing the nominations. President Portale reflected on the life of Harold J. "Whitey" Swartz for whom the awards are now named in honor of. Whitey passed in March of 2017 and was affiliated with the fire service his entire life. Whitey grew up in Pleasantville by the firehouse where he delivered their paper and helped them out as a child. It was there that he received his nickname "Whitey" for the white hair he had since his youth. Whitey served in the military after school and tested to join the Pleasantville Fire Department afterwards. Whitey retired from the fire department as a Battalion Chief to then serve many years as the Atlantic County Fire Marshal. Whitey had spent many years working with this association and it was he that started the valor awards twenty-seven years ago and then the service recognition nine years ago. President Portale noted that it was only fitting that these awards be named in his honor. Executive Committee Chairman Howard Berchtold noted that it was good to see Chaplain Sweeny in good health and back to it after recovering from back surgery. Howard spoke about the fire service being a family and how it was an honor to be able to recognize all the award recipients. Howard reminded all that this association and the government of the County of Atlantic worked together to open the Anthony "Tony" Canale Training Center twenty-five years ago and reported that something will be planned for later in the year to recognize that. President Portale welcomed and introduced guests: Michael Francis on behalf of Congressman Frank LoBiondo; NJ Assemblyman John Armato; and Atlantic County Freeholders: Vice-Chairwoman Maureen Kern, John W. Risley, and Caren L. Fitzpatrick, All invited guests offered words of gratitude for the local fire service and the honored award recipients. President Portale thanked all the invited guests for attending, the association officers and executive committee for all the work that they do, all county firefighters, and their families that support them, tonight's valor award recipients for being in the right place at the right time, and all the "50" years of service recipients for their dedication to the fire service.

Battalion Chief Scott Trythall, Pleasantville Fire Department, highlighted the details surrounding the January 30, 2017 incident that earned recognition for Acting Captain Pete Bowker, Firefighter Gary Guerra, and Firefighter Stan Kolbe.

On January 30, 2017 Acting Captain Bowker, Firefighter Guerra, and Firefighter Kolbe successfully rescued a trapped occupant from a structure fire on Sixth Avenue in Pleasantville.
